On organization of missions of medical workers who volunteered to provide medical aid in the area of activities aimed at ensuring national security and defense, rebuffing and holding back the armed aggression of the Russian Federation in Donetsk and Luhansk Oblasts

In accordance with Article 8(1) of the Law of Ukraine "On the state policy of ensuring the state sovereignty of Ukraine on the temporarily occupied territories in Donetsk and Luhansk Oblasts",

clause 8 of the Regulations on the Ministry of Health of Ukraine, as approved by Cabinet of Ministers of Ukraine Resolution No. 267, dated March 25, 2015,

and the Memorandum of Cooperation within the framework of the Project "Pirogov First Volunteer Mobile Hospital," dated Feb. 5, 2016, between the Ministry of Health of Ukraine, the Ministry of Defense of Ukraine, the General Staff of the Armed Forces of Ukraine and the Charitable Foundation "Pirogov First Volunteer Mobile Hospital,"

and in order to respond timely to the need of providing emergency and specialized medical aid to civilian population, servicemen and law enforcement personnel in the area of activities aimed at ensuring national security and defense, rebuffing and holding back the armed aggression of the Russian Federation in Donetsk and Luhansk Oblasts,

I HEREBY ORDER:

1. The heads of the health care units within the Donetsk and Luhansk Military-Civilian Administrations:

- 1) To ensure accommodation and admission to working at your subordinate health care institutions for medical and non-medical workers who arrive within the framework of the Pirogov First Volunteer Mobile Hospital project to work at health care institutions in the area of activities aimed at ensuring national security and defense, rebuffing and holding back the armed aggression of the Russian Federation in Donetsk and Luhansk Oblasts;
- 2) Before the 15th day of every month, to inform the Health Ministry Emergency and Disaster Medicine Department, the Joint Operational Staff of the Armed Forces of Ukraine (hereinafter referred to as Operational Staff) and the Pirogov

First Volunteer Mobile Hospital foundation on your needs of engaging medical and non-medical workers within the framework of the Pirogov First Volunteer Mobile Hospital project to work at medical institutions located in the area of activities aimed at ensuring national security and defense, rebuffing and holding back the armed aggression of the Russian Federation in Donetsk and Luhansk Oblasts;

- 3) Before the 30th day of every month, to inform the Health Ministry Emergency and Disaster Medicine Department on the number of medical and non-medical workers who arrive within the framework of the Pirogov First Volunteer Mobile Hospital project to work at health care institutions in the area of activities aimed at ensuring national security and defense, rebuffing and holding back the armed aggression of the Russian Federation in Donetsk and Luhansk Oblasts;

2. The Emergency and Disaster Medicine Department:

- 1) In conjunction with the Operational Staff (subject to its consent), to determine the needs of health care institutions in the area of activities aimed at ensuring national security and defense, rebuffing and holding back the armed aggression of the Russian Federation in Donetsk and Luhansk Oblasts for medical and non-medical workers in compliance with the procedure prescribed by law;
- 2) To inform the health care units within the Oblast State Administrations and the Kyiv City State Administration, as well as the state health care institutions and enterprises and higher education institutions within the purview of the Health Ministry, on the needs of engaging medical and non-medical workers (given their voluntary statement of will in writing) within the framework of the Pirogov First Volunteer Mobile Hospital project to work at health care institutions in the area of activities aimed at ensuring national security and defense, rebuffing and holding back the armed aggression of the Russian Federation in Donetsk and Luhansk Oblasts;
- 3) In conjunction with the Pirogov First Volunteer Mobile Hospital foundation (subject to its consent), to draw up monthly reports on meeting the needs of engaging medical and non-medical workers (given their voluntary statement of will in writing) within the framework of the Pirogov First Volunteer Mobile Hospital project to work at health care institutions in the area of activities aimed at ensuring national security and defense, rebuffing and holding back the armed aggression of the Russian Federation in Donetsk and Luhansk Oblasts;

3. The heads of the health care units within the Oblast State Administrations and the Kyiv City State Administration, as well as the state health care institutions and enterprises and higher education institutions within the purview of the Health Ministry, to ensure:

- 1) In conjunction with representatives of the Pirogov First Volunteer Mobile Hospital foundation (subject to its consent), informing medical and non-medical workers of your subordinate health care institutions, enterprises and organizations on opportunities for being sent on a mission, given their voluntary

statement of will in writing, to the area of activities aimed at ensuring national security and defense, rebuffing and holding back the armed aggression of the Russian Federation in Donetsk and Luhansk Oblasts within the framework of the Pirogov First Volunteer Mobile Hospital project;

- 2) Given their voluntary statement of will in writing, detaching medical and non-medical workers of your subordinate health care institutions, enterprises and organizations and placing them at the disposal of Operational Staff within the framework of the Pirogov First Volunteer Mobile Hospital project in compliance with the procedure prescribed by law;
- 3) Reimbursing costs incurred by the medical and non-medical workers on the mission in compliance with the procedure prescribed by law;

4. To invalidate Order of the Ministry of Health of Ukraine No. 1254, dated Nov. 18, 2016, "On organization of missions of medical workers who volunteered to provide medical aid in ATO areas."

5. To charge Deputy Minister Oleksandr Linchevsky with oversight of execution of this order.
